2024-4461 RESOLUTION TO SUPPORT THE QUEBEC GOVERNMENT'S ANALYSIS OF THE PROPOSAL TO CREATE A PROTECTED AREA IN THE MUNICIPALITY OF BONNE ESPERANCE.

WHEREAS Quebec has adhered to the new Kunming-Montreal Global Biodiversity Framework, whose flagship target is to conserve 30% of the world's land and oceans (target 3) by 2030;

WHEREAS the Government of Quebec launched a call for projects for protected areas on southern public land on June 5, 2018, open to all and aimed at collecting proposals for protected areas from stakeholders from various backgrounds;

WHEREAS in order to achieve this new target, municipalities and MRCs are called upon to play a leading strategic role because of their expertise in land use planning;

WHEREAS Quebec currently protects nearly 17% of its continental territory, and ecosystems south of the 49th parallel are under-represented;

WHEREAS the Municipality wishes to play an active role in the protection of the natural and semi-natural environments of its territory;

WHEREAS under the *Natural Heritage Conservation Act* (CQLR, c. C-61.01), a protected area is a clearly defined geographical area that is recognized, dedicated and managed, by any effective means, legal or otherwise, to ensure the long-term conservation of nature and the ecosystem services and cultural values associated with it;

WHEREAS the government will carry out phases of analysis and consultation and will make it possible to adequately characterize the territories and gather all the information necessary to take an informed position on the territories to be protected as a priority in the region;

WHEREAS the prioritization of the territories to be protected will take into account the vision of the Municipality of Bonne Esperance;

WHEREAS the next step, in the fall of 2024, is a pre-analysis of the projects by the ministries concerned;

WHEREAS the municipality is requesting a review of the current boundaries of the protected area reserve, proposed by the Government of Quebec;

WHEREAS the municipality is requesting that the rights of occupancy be granted for vacation purposes, as well as the possibility of future development of facilities for the withdrawal of water for municipal purposes;

WHEREAS the municipality is asking for a reasonable grant of the rights to install sand and gravel pits;

WHEREAS the effect of this resolution is not to approve the proposed territories but to agree that the proposed territories be analyzed;

**THEREFORE**, it was proposed by Angela Spingle, and seconded by Garland Nadeau and unanimously resolved:

**THAT** the Council of the Municipality of Bonne Esperance support the Government of Quebec's analysis of the proposed protected area.
