


It is proposed by Leon Keats, seconded by Garland Nadeau and

unanimously resolved to close the sitting at 9:26 pm.



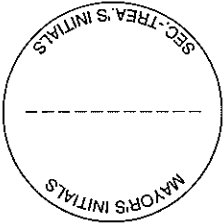
