BY - LAW R0123

ESTABLISHING THE REAL ESTATE TAX AND
TARIFFS FOR THE 2024 FINANCIAL YEAR OF
THE MUNICIPALITY OF BONNE-ESPERANCE

WHEREAS a notice of motion of the present by-law was given at a council sitting held on January 15, 2024

CONSEQUENTLY, it is proposed by Angela Spingle, seconded by Garland Nadeau and unanimously resolved that the council orders and decrees by the present By-Law as follows:

SECTION I. GENERAL TAX ON REAL ESTATE VALUE.

ARTICLE 1-1

That a tax of \$0.8790 per \$100. Value entered in the assessment roll, be set and imposed for the 2024 financial year, on any taxable immovable located in the territory of the municipality.

SECTION II TARIFFS FOR WASTEWATER SERVICE

ARTICLE 2-1

That be required and imposed for the 2024 financial year to all property owners in St. Paul's River and Vieux Fort serviced by the wastewater system, the annual tariffs of \$166.22 multiplied by a factor expressed in units such as follows with regards to cash category:

SECTION III TARIFF FOR THE WATER SERVICE.

ARTICLE 3-1

That be required and imposed for the 2024 fiscal year to all property owners serviced by the waterworks, the annual tariff of \$359.91 multiplied by a factor expressed in units such as stated in the following with regard to each category and its users.

ARTICLE 3-2	
In all cases, the tariff for the water service must be paid by the owner.	
SECTION IV	
TARIFF FOR THE GARBAGE COLLECTION AND DISPOSAL SERVICE.	
ARTICLE 4-1	
That be required and imposed by the 2024 fiscal year to all property owners serviced by the garbage waste collection and disposal the annual tariff of \$240.24 multiplied by a factor expressed in units such as stated as follows with regard to each category and its users.

ARTICLE 4-2

In all cases, the tariff for the garbage collection and disposal service must be paid by the owner or occupant.

SECTION V.

TARIFF FOR THE SNOW REMOVAL SERVICE

ARTICLE 5-1

That be required and imposed by the 2024 fiscal year to all property owners in St. Paul's River, Old Fort Bay and Middle Bay serviced by the snow removal service such as stated in the following with regards to each category and the users.

ARTICLE 5-2	In all cases, the tariff for the snow removal service must be paid by the owner.
SECTION VI	
ARTICLE 6-1	TARIFF FOR VACANT LAND
	That be required and imposed for the 2024 fiscal year to all property owners who are holding vacant land for a period of two years or more, the annual tariff of \$300 on any taxable immovable located in the territory of the municipality of Bonne Esperance.

SECTION VII

COMING INTO FORCE

ARTICLE 7-1

The present by-law will come into force according to the law.
