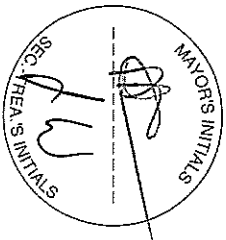


Question Period
