2024-4429 RESOLUTION TO REQUEST FINANCIAL ASSITANCE FROM PUBLIC SECURITY FOR FIREFIGHTER I & II TRAINING FOR OUR VOLUNTEER FIRE FIGHTERS

Whereas the regulation respecting the conditions of employment with a municipal fire department sets out the training requirements for firefighters in municipal fire departments to ensure a minimum professional qualification;

Whereas the purpose of this by-law is to guarantee municipalities the training of firefighting teams with the skills and abilities required to respond effectively in emergency situations;

Whereas, in April 2024, the Quebec government established a new financial assistance program for firefighter training;

Whereas the main objective of this program is to provide municipal organizations with financial assistance to enable them to have a sufficient number of qualified firefighters to act safely and effectively in emergency situations;

Whereas this program is also intended to improve the disaster response capabilities of these municipal organizations' SSIs, to help them prepare for potential emergency situations and to respond quickly and appropriately when such events occur, thereby reducing their impact on life, property or the environment;


